



Summary of Mathematica Educational Site License

Concordia University (the “University”) now has an educational site license for Mathematica software from Wolfram Research.

Overview of the Mathematica Educational site license

- An educational site license is a subscription licensing program for higher educational institutions
- It is a simple way to get Mathematica licenses to faculty and staff (collectively “Employees”) and students of the University
- The cost of the educational site license is based on the number of Employees and not on the number of computers owned by the University
- The licensed software can be installed on any computer owned by the University at no cost, for use by an Employee for University instruction and academic research
- The software can be installed on an Employee’s or a student’s personally owned computer located at the home and primarily used to support instruction and academic research.
- The Employee or the student must agree to the Concordia Acceptance form and must provide their email address to Wolfram Research Inc.

Software products covered by the site license

Only Mathematica software and available add-ons, if any, are covered by this site license. Add-ons offered may change, at any time, at Wolfram Research’s discretion.

The software can be installed on University owned computers or on an Employee’s or student’s personally owned home computers. In the first case, a request must be made to University IT staff. Only English versions of the software will be deployed on University owned computers.

At no time will IITS (or any University IT staff) distribute Mathematica software in any format (CD, DVD, ISO image, etc.).

Purchasing Practices

Any purchase request for software products **COVERED by the Mathematica Educational site license WILL NOT BE AUTHORIZED** by the University's Purchasing Services Department.

Any purchase request for products **NOT COVERED by the Mathematical Educational site license MUST BE APPROVED**, as part of standard purchasing procedures, by the University's Purchasing Services Department.

Home-Use Mathematica license program

The University's Mathematica Educational site license allows for the download of home-use licenses by Employees and students to be used on a personally owned computer at the Employee's or student's residence primarily for the use or support of instruction and academic research.

The Employee or the student will have to agree to a Concordia Acceptance Form and to the terms and conditions of Mathematica's Home-Use License Agreement found at <http://www.wolfram.com> and must register on the Wolfram Research web site.

When completing this registration, an Employee or student must ensure the following:

(i) if delivery at home is selected, any fee paid by an Employee or student shall **not** be reimbursed by the University

(ii) provide the requested personal info to Wolfram Research, including first name, last name, email address and Concordia net name (it is imperative that the Employee or the student always indicate a Canadian address and explicitly use the following URL <http://www.concordia.ca/directory/index.php>. This will allow Wolfram Research to verify the Employee's or student's status with the University).

No technical support will be provided by the University's IT staff or by Wolfram Research for home use of the software.

The software obtained for home-use is registered to the Employee or to the student and may not be transferred. Furthermore, the Employee or the student will have to remove the software from their personally owned computer immediately upon expiration of the University's licensed period or earlier if their relationship with the University comes to an end.
