

**Extended Term Appointment

The Department of Chemistry and Biochemistry invites applications for an extended-term appointment to teach physical, analytical chemistry at the introductory level as well as entry-level general chemistry. Applicants should have a PhD in chemistry or a related field with formal teaching experience at the University level and a strong commitment to undergraduate education. Experience in teaching environmental chemistry and/or interdisciplinary approaches to teaching general chemistry will be an asset.

Applications should consist of a cover letter, a current curriculum vitae, a statement of teaching philosophy/interests, and evidence of teaching effectiveness. Teaching effectiveness is the key attribute by which applicants will be judged. Candidates should arrange for three letters of reference to be sent directly to:

This position is subject to budgetary approval and department/unit need. Individuals holding extended-term appointments may be granted a subsequent appointment, given continued funding and need, as well as satisfactory job performance. Initial appointments are normally at the rank of Lecturer or Assistant Professor, beginning June 1, 2019 and ending May 31, 2022. Successful candidates will normally be expected to teach six, 3-credit courses per year and serve on relevant department committees.
