FIELD LOG:

Due to logistical problems, I was unable to initiate this research until the first week of August. This resulted in a series of limiting factors which were unavoidable. The first was that it was the height of the tourism season and many business people and individuals in the voluntary sector did not have time for an extended interview. Informal, ten to twenty minute chats were the order of the day, I found. Secondly, many other people were on holiday. It is undoubtedly better to do this research outside the Summer months.

Those who took the time out to be interviewed were very friendly and happy to discuss many issues. However, they did not like the structured interview format and could not be bothered with many of the quantitative style selection questions which they found hard to understand and complex in correct execution.

Unlike Winterton, a variety of people remembered the visit of Shirley Dawe in 1998 and still had some interest in what the project was doing. Those in the business sector, however, were sceptical of the worth of the survey. One individual summed up the attitude by saying that over the last eight years since the cod moratorium "everybody" had researched what's wrong with communities in Newfoundland, but "nobody" had come up with any decent solutions yet.

My primary point of contact was the Town Hall, but nobody was available from there until the last day of my stay in Twillingate. Most people were very helpful and informative when they could be pinned down to a time and place.

I have to say, as a person new to Newfoundland, that in this community and Winterton, I have experienced a decided antipathy and scepticism toward this sort of research.

The only key formal contact that has changed since 1998 is the Mayor, whose name is now Earle Rideout.

4. SITE HISTORY - MAJOR EVENTS & STORIES

The two main developments since the codfishery collapse of 1992 are undoubtedly the growth of tourism markets on the island and the hiatus surrounding an attempt to reopen the local fish plant.

Tourism has grown enormously in the last five years or so, with seasonal B&Bs becoming a standard method of income enhancement for many. As well as the current museums and whale boat tours, there are advanced plans to develop a variety of new initiatives including a historical village of the nineteenth century with characters in costume and a new park that will offer various sporting activities like kayaking and have cabin residences (aimed at the international market). There are currently many infrastructure improvements underway (causeway upgrade, wharf and water system upgrades) that are certainly part and parcel of this attempt to become even more

appealing to the tourist. Twillingate is definitely now a leading light for successful tourism development in the province.

This positive picture is marred by a deep frustration at what happened with the local fish plant some years ago. Many of the town's people are convinced that the Provincial government called in the \$2 million loans of six local men who acquired the plant and processing license in order to sell it for \$400 thousand to the best friend of a cabinet minister. This allegation has deeply affected leading lights of the community as they see it as having been sold off so that it would not be used for processing in direct competition to the individual who bought it. As a result, the crab 'tycoons', as they call them, are not popular people in a town which still wants to be a fishing town more than anything else. They are passionate believers in a redistribution of existing licenses and quotas so that more people can make a reasonable living rather than a few becoming millionaires.

This story undoubtedly has many sides and inaccuracies, but the fact is that it is generally believed and has had a real effect on the people of Twillingate's morale and opinion of government. Several people voiced the belief that Twillingate would be nothing more than a retirement home in twenty years time.

This Summer was 'Come Home Year' in Twillingate, coinciding with the annual 'Fish, Fun and Folk Festival' in the last week of July.

7. ECONOMIC FORTUNES

No Chamber of Commerce and some confusion exists locally over whether the Business Association exists or not. There has been considerable local acrimony concerning this organisation.

No comprehensive list of any kind was forthcoming, even from those in economic development. No person interviewed believes that there have been any business closures since 1998, although many have changed hands in recent months, which backs up the claim by some business people that many are struggling.

New businesses referred to were the new B&Bs (estimated at 5-6) and the Lighthouse museum/ craft shop.
