

The Veterans Administration (VA) offers educational support for Veterans and other eligible persons attending Concordia University.

This program can provide funding for your tuition, fees, housing, and books and supplies. Your required documents, enrollment declarations, satisfactory progress and attendance standards are regulated by the VA. The VA will only provide benefits for programs approved by the VA.

Before submitting this form: If you are a first-time student, you must make sure that you have filed an application for Benefits with the VA. If this is your first time applying for enrollment certification, you will need to file an application for Benefits directly to the US Department of Veterans Affairs online.

If you don't have access to apply online, you can call **1-888-442-4551** and ask that an application be mailed to you. Veterans and other eligible persons must contact VA directly with any questions about his or her eligibility or payments, or to apply for benefits. Once eligibility is determined, the VA will provide the student with a certificate of eligibility.

The certificate of eligibility must be submitted to the Financial Aid Office along with any other required documents as directed. If you have questions about VA education benefits, please call 888-442-4551, Monday through Friday, 8:00 a.m. to 7:00 p.m. ET.

### **Important Information:**

Special update for Students: Section-1102 Continuation of Educational assistance benefits during COVID 19. The exemption for receiving the monthly housing allowance and GI benefits for online courses has ended. When enrolling for courses in students will need to enroll in approved resident (in person) classes to continue receiving benefits.

- For Chapter 33 students ONLY: Beneficiaries must verify their enrollment status each month for enrollment periods which begin on or after August 1, 2021, to continue to receive their monthly housing allowance (MHA) and/or kicker payments. Students may choose to do this by Text Message, Telephone or Email.

- Public Law 116315, Johnny Isakson and David P. Roe, M.D. Veterans Health Care and Benefits Improvement Act of 2020, Section 1019: Students may end up owing a tuition debt to your school (VA will charge the school a prorated tuition and fee debt which the school may, in turn, pass on to the student) if there is a change in enrollment.
