Dr Venkatesh explained that this proposed certificate, an initiative by the School of Graduate Studies and the first English-language 'for credit' program of its kind in Canada, will be open to current Concordia PhD students and will use an apprenticeship approach where students are mentored by a faculty member. It is not intended for students who already receive significant pedagogical training as part of their doctoral program. Students are expected to complete the program over 3 terms and will be required to pay tuition fees; conversely, the teaching seminar is remunerated. The certificate builds on a partnership with the Centre for Teaching and Learning and will be under the directorship of the INDI program. It will rely on current resources, however, should enrolments increase, the current personnel situation in INDI will be complemented accordingly.

Dr Venkatesh requested speaking privileges for Prof. J. Locke, Dr M. Sharma and Dr J. Didur. Dr Didur explained that the proposed PhD program has been a long time in the making and builds on a highly successful master's program. The Department of English has a strong record of acquiring external grants including a Concordia University Research Chair in Media and Contemporary Literature, and a scheduled CURC in the Digital Humanities. The program differentiates itself markedly from others in the Montreal area by allowing for a stronger focus on literary studies yet its structure is fairly open to accommodate current and varied research themes as well as those that are emerging.

Dr Venkatesh requested speaking privileges for Dr M. Mulrennan. Dr Mulrennan provided Council with an overview of the program and explained that it builds on the department's current MSc as well as its MEnv program. She further noted that the PhD responds to an urgent need in the department not only to maintain its excellent ranking amongst its peers across Canada and internationally, but also to provide supervision opportunities for faculty members which, in turn, benefit faculty retention. The program has been designed to encourage timely completion and is well slated to provide employment to graduates in the 'green economy'. Dr Mulrennan stated that internal funding for potential candidates is key but that the bulk of students in the field tend to be self-funded.
