# 6. FAS Future Directions: A Living Document, ASFC 2016-5M-C

Concordia University initiated a strategic planning exercise over a year ago and established nine future directions that would guide the university. These directions were then used to initiate a second phase of the planning process, in which major initiatives and other connected directions would emerge within this context. Faculties were invited to develop their own plan and to establish their priorities.

The Faculty embarked on its own process with the following main stages:

- A survey was distributed to all 27 academic units. Information was collected in order to determine constituent opinion on various matters, including their own vision for 2025.
- A wide consultation took place, with the Dean and his team meeting over 150 constituents (chairs, faculty, staff, and students).
- Presentations were made at Chairs meetings, Academic Cabinet, Faculty Council on April 1 and at Senate on May 13.

The FAS 2025: A Living Document makes a strong statement about who we are as a Faculty. The starting point is that the FAS is a federation of foundational disciplines with a vision of leading interdisciplinary thinking and initiatives. Interdisciplinarity, which is a core value of the FAS, cannot exist without disciplines contributing to the latter.

The document is a shared vision about what the FAS is and what it could be in 2025. It also details principles for action, along with big-banner projects under which initiatives can take place. The document is unique in that it does not explicitly resemble a strategic planning document, nor is it labelled as such. Rather, its purpose is to be a platform that helps the Faculty and its constituents establish its position and academic leadership as of May 2016, but that also allows room for change and discussion.

This planning process is an opportunity to create a strong future and identity, and the document is a demonstration of the Faculty's strength as a federation within Concordia.

#### Feedback received:

Francine Tremblay expressed interest in clarifying the concept of consensus and wishes to see young faculty members included in the planning process.

Dean Roy offered that the Faculty is open to criticism, challenges, and discussions, but also reiterated the importance of representing the FAS as a collective unit. As well, he offered that young faculty members were indeed consulted and their ideas engaged with.

Greg Nielsen offered that the mission detailed in the living document was clear and that the process was a transparent one.

Eric Buzzetti raised concern over the question of how authority is determined to decide which ideas are selected and supported by the Faculty.

Dean Roy offered that the ideas in the living document were borne out of recurrent feedback that was submitted with the questionnaires and common themes that came through across constituencies. Recurrence and commonality thus guided inclusion of ideas in the document.

Kimberley Manning commented that, especially in terms of sustainability and indigenous studies, the Faculty must look critically at what universities tend to privilege as knowledge. Dr. Manning mentioned that Concordia University should be at the forefront of challenging ideas about what should be considered core knowledge.
