Riverside School Board Sylvain Racette has been the Director General of Riverside School Board since May 2010. Prior to his appointment at Riverside School Board, Mr. Racette was a Ministry representative on the Management Negotiating Committee for English Language School Boards (CPNCA) where he acted as Chief Negotiator at the Provincial Teachers' Negotiation Table for the English school boards from March 2009 to May 2011. He remains, to this day, a member of the Board of Directors of CPNCA.

Since 2018, Mr. Racette has been the President of the "Association of Directors General of English School Boards of Québec" (ADGESBQ).

He is also a member of the Executive Committee of the "Association des Directions générales des Centres de Services et Commissions Scolaires" (ADIGECS). As such, he sits on multiple strategic advisory groups of the Ministère de l'Éducation and to the Minister himself.
