- Midterm Test:** There will be one midterm test, based on the material of Weeks 1-7, which will contribute up to 25% to your final grade (see the Grading Scheme below). Missed tests cannot be made up. The midterm test will be held on **Tuesday, March 7, 2023** in class. This exam and the final will be closed book exams.
- NOTE:** It is the Department's policy that tests missed for any reason, **including illness**, cannot be made up. If you miss the midterm test because of illness ([Short-Term Absence form](#) or valid medical note required); the final exam will count for 85% of your final grade, and the assignments will count for the remaining 15%.

**Final Exam:** The final examination will be three hours long and will cover all the material in the course.

**NOTE:** Students are responsible for finding out the date and time of the final exams once the schedule is posted by the Examinations Office. Conflicts or problems with the scheduling of the final exam must be reported directly to **the Examinations Office, not to your instructor**. **Final Grade:** The final grade will be based on the higher of **(a) or (b):**

- a) 15% for the assignments, 25% for the class test, and 60% for the final exam.

If the grading scheme for this course includes graded assignments, a reasonable and representative subset of each assignment may be graded. Students will not be told in advance which subset of the assigned problems will be marked and should therefore attempt all assigned problems.
