If the grading scheme for this course includes graded assignments, a reasonable and representative subset of each assignment may be graded. Students will not be told in advance which subset of the assigned problems will be marked and should therefore attempt all assigned problems.

- (4) In order to obtain a good grade, the student **must show** that they have a **thorough** understanding of the subject and can fully explain **their reasoning** process in the context of their problem solutions.
