#### **Recent Events**

James B. Kelly co-organized a meeting of IPSA's Research Committee 9 (Comparative Judicial Studies) at the Monash University Prato Centre in Prato, Italy, July 24-26, 2019. The conference was entitled "Democracy, Populism, and Judicial Power" and was co-sponsored by the Clark Centre for Australian and New Zealand Studies at The University of Texas at Austin, the Monash University Prato Centre, and RC09 (Comparative Judicial Studies). Thirty participants attended from 15 countries.

James Moore, Distinguished Professor Emeritus, delivered a lecture on "Epicureanism and Scepticism in the moral philosophy of David Hume" at a workshop on John Robertson's Enlightenment at Christ Church, Oxford on September 27<sup>th</sup>, 2019.

This year's Public Servant in Residence Speaker Series' first conference was a conversation between David Heurtel and Ivan Vrana. Mr. Vrana is an Adjunct Professor in the department and teaches a graduate summer course every year on the Mechanics of Policy-Making. The discussion centered on legislation following the recent legalization of cannabis.



Several members of the department participated in the 2nd Concordia-McGill African Studies Conference on "Rethinking Africa's Urban Futures," October 3 - 4, 2019. This event was hosted by the Concordia African Studies Working Group.

Henri Habib, Distinguished Professor Emeritus, analysed the Trump Peace Proposal for the Isreal-Palestine conflict and its effects on the recent regional problems affecting the withdrawal of the USA from Syria on November 12th, 2019.





On October 29th, Vicki Prais, a London-based human rights lawyer, gave a lecture to Concordia students on the opportunities and challenges involved in pursuing a career in human rights. This was the first lecture in the Department's Human Rights Lecture Series, organized by Nicole De Silva.

The Concordia African Studies Working Group hosted Anne-Maria Makhulu (Duke University) for two events in November 2019. On November 14th, she gave a public lecture on "South Africa after the Rainbow: Aspiration, Ambition, and Social Mobility." The following day, she led a graduate seminar on welfare, resistance, class, and monetization in post-apartheid South Africa. These events were supported by the Department of Political Science, as well as the Departments of Sociology and Anthropology, English, and History, and the Centre for Interdisciplinary Studies in Society and Culture.





Meghan Joy led a talk entitled "What is an Age Friendly City Anyways?!" for the engAGE (aging research at Concordia) 'Beyond the Body' Summer School on July 4th, 2019. She also gave a 'lightning talk' on the health-related dimensions of her research on age friendly cities for Concordia's Health Challenge Networking Event on December 4th, 2019.
