Inter-University Graduate Student Conference, March 15-16

The four Montreal universities graduate student associations (Concordia, McGill, Université de Montréal, and Université de Québec à Montréal (UQAM)) invite you to the first Inter-University Political Science Graduate Conference.

The event will take place on March 15th and 16th, 2018, and will mix formal presenter/discussant panels with opportunities for less structured conversations such as roundtables and workshops. The aim is to encourage students, faculty members and non-academic professionals to share experiences, perspectives, research, and ideas about improving teaching, practicing, and learning in political science in different cultural and linguistic contexts.

The program for the two-day conference includes a Graduate Workshop on making universities more inclusive, a round table with Graduate Program Directors, and a keynote address by Malinda Smith from University of Alberta.
