Patrik Marier has been awarded a Concordia University Research Chair (CURC) in the area of Aging and Public Policy.




Mireille Paquet's Ph.D. Dissertation, titled "Les provinces et la fédéralisation de l'immigration au Canada, 1990-2010" received Laval University's Vincent Lemieux Prize (2015): "Mireille Paquet's dissertation makes a significant contribution to studies of federalism/federalisation and of immigration and is very well written. This is very impressive work that does not simply test a theory but really takes us a step further in our understanding of key concepts in the literature and reveals critical insights on how provincial governments came about to be active players in the field of immigration. Its contribution is thus theoretical but also offers a better understanding of key social and policy changes. The fieldwork is very impressive, going through all ten provincial cases, and well guided by both a sound theoretical framework and a strong methodology."

Mireille Paquet's article, "The Federalization of Immigration and Integration in Canada" (*Canadian Journal of Political Science* 47(03): 519-548) was shortlisted for the 2015 John McMenemy Prize given to the Best Article Published in the Canadian Journal of Political Science.

Mireille was also the runner-up for the Léon-Dion Prize for her article "La construction provinciale comme mécanisme: le cas de l'immigration au Manitoba" published in *Politique et Sociétés* (33 (3), 2014: 101-130). The Léon-Dion Prize is awarded every second year by the Société québécoise de science politique to the author of the best article published in *Politique et Sociétés* over the two years preceding the granting of the award at the annual meeting of the Société.
