### foreword from the principal

After two years at the Simone de Beauvoir Institute (SdBI), I am proud to report that the SdBI has maintained its distinguished record in teaching, research grants and publications, as well as in service to the wider community. I am extremely grateful to all the part-time and fulltime professors, Fellows, Research Associates, and members of the Women's Studies Student Association, who have shared their perspective and experience as members of our committees or participants in our events. Their wonderful contributions keep our Institute vibrant. I also owe gratitude to Linda Bowes, our Program Secretary, and our Events Coordinators/ Information Officers Melissa-Anne Cobbler (2009-2010) and Michelle Lacombe (2010-2011): their tireless efforts have made my work so much easier and their help has rendered possible the present report.

The face of the SdBI is constantly changing. We have managed to obtain support from the Faculty of Arts and Science to renovate our classroom, to refresh our lounge area and a number of the offices, as well as to revamp our website and publicity materials. We have redesigned our organizational structure to give our Coordinating Committee more flexibility and more ease in the decision-making process. For the first time in its history, the SdBI has enough staff to be able to manage its own Personnel Committee, Hiring Committee, and Tenure Committee. Our Part-Time Professors, Fellows and Research Associates have also insured the continuation of the steady work of our standing committees (Curriculum, Graduate, Ethics, Forum, Lillian Robinson Scholar Program) and great strides have been made in our SdBI projects.

In the last two years, at the UNDERGRADUATE LEVEL, our programs have continued to attract a large number of applicants and our student body

has been increasing in the last three years. Fulltime and part-time professors have teamed-up to offer demanding and cutting-edge courses. Our Curriculum Committee has worked hard to refresh and strengthen all four of our programs and the new and exciting programs should be in place for September 2012. The Curriculum Committee has also forwarded a proposal for a new Major in Interdisciplinary Studies in Sexuality. If accepted by the University and the province, this program would likely start in September 2013.

At the GRADUATE LEVEL, our Graduate Committee has also been very busy and has managed to get approval for a special "Research Current" as part of the Special Individualized Program (SIP). This means that both at the Master's and Ph.D. levels, graduate students are now able to register into a Women's Studies SIP. In addition, the Graduate Committee has prepared a proposal for a Master's degree in Critical Studies of Activism that will allow students to further feminist scholarship in two areas: (a) bodies, genders and sexuality; and (b) race, nationalisms, and states. This proposal should be sent to the Faculty of Arts and Science in the Fall of 2011, with a beginning of the new program predicted for September 2013.

In the last two years, at the POSTDOCTORAL LEVEL, the Institute has welcomed a good number of Postdoctoral Fellows. Drs. Haïfa Tlili, Shannon Jette and Moss Norman have worked with me on a major research project dealing with young women's discursive constructions of health and the body in the context of a dominant "obesity discourse," while Dr. Marilou Gagnon has worked under the supervision of Dr. Viviane Namaste and pursued projects dealing with people living with HIV/AIDS and their bodily experiences of Highly Active Antiretroviral Therapy (HAART).

In terms of RESEARCH, all full-time professors have continued to be very active. A fuller account of their research outputs can be found later in the Report, but it is worth highlighting here that their most recent publications and presentations constitute only a fraction of their work as researchers and that their writing efforts of the last two years should soon be rewarded by the fresh smell of their books coming off the press! Full-time professors continued their stellar record of obtaining important research grants with research councils such as the Social Sciences and Humanities Research Council of Canada, the Fonds guébécois de la recherche sur la société et la culture, and the Canadian Institutes of Health Research. The Institute received considerable publicity this year, with Drs. Namaste and Maillé getting extensive press coverage for their research and their views as experts. As you can also see in the present document, our Fellows, Part-Time Professors, Research Associates, and Postdoctoral Fellows greatly contributed to the advancement of feminist knowledge and praxis via their multiple success as awards and grants recipients, and as authors of important and relevant publications and presentations. Notably, Dr. Shannon Jette was awarded a CIHR Postdoctoral Fellowship (2010-2012) and Drs. Valerie Behiery and Rena Bivens were both awarded a SSHRC Postdoctoral Fellowship (2011-2013). SdBI Fellow Dr. Stephanie Paterson's outstanding work was recognized by the 2010 Faculty of Arts and Science Dean's New Scholar Award and three Research Associates received recognition as well: Rachel Dubrofsky (2009 Faculty Appreciation Award from the Graduate Communication Association, University of South Florida), Dr. Caroline Kelly (2009 Goldwell Open Air Museum Fellowship) and Dr. Candis Steenbergen (2009 John Abbott College Dean's list recipient of the 'Special Teacher' Recognition).

With regards to COMMUNITY OUTREACH, all full-time professors were involved in the organization of significant conferences and events, and all devoted their time to community service and feminist praxis. Dr. Namaste made us particularly proud, getting her promotion to Full Professor and receiving a total of four prizes for her contributions to research and community (Hot shot 2009 from Hour Magazine, 2009 Award for action on HIV/AIDS from the Canadian HIV/ AIDS Legal Network and Human Rights Watch, Prix 2010 Hommage aux héros from the Farha Fondation, Grand prix 2010 du Conseil québécois des gais et des lesbiennes). Space prevents me from presenting the extraordinary achievements of other SdBI members, but suffice to say that their contributions have been noticed and have greatly contributed to sustaining the excellent reputation of the SdBI in the community. Our Forum Committee has been very active and, for the last two years, has managed to sponsor and/ or organize seminars, colloquia, conferences, book launches, receptions, and a good number of other feminist activities; some of the highlights are presented later in this report. These activities have added to the fabulous Feminist Café events organized around the visit of four recipients of a Lillian Robinson Visiting Scholarship: Drs. Marie-Hélène Bourcier (2009-2010), Erica Meiners (2009-2010), Emily van der Meulen (2010-2011) and MJ Thompson (2010-2011).

In brief, the flourishing state of the SdBI is underscored by the collective accomplishments of the various SdBI actors between 2009 and 2011 and, of course, only a tiny fraction of those can appear here. I would like to take the opportunity to thank all members of the SdBI for such amazing work and to congratulate students and staff for two years of outstanding achievements. I warmly welcome the members who have recently joined us and wish those who are leaving success and happiness in their futures.



#### 2010-2011


We offered nine sections of 200-level courses with a total enrolment of 292 students. We also offered eleven 300-level courses with a total enrolment of 186 students, in addition to eight 400-level sections with a total enrolment of 119 students.





Women's Liberation Groups

Beginning in the latter half of the 1960s, an explosive mix of Cold War and New Ell policies garked Canada's RCVI Security Services to cast its surveillance sophistication and their increasing recognition of the varieties of left-wing radications, surveillance of women's liberation groups seriously challenged the force. Gender was the key variable at work. However, the interaction of ender with other variables such as class position, racial and ethnic origins, age, sexuality and political ideologies (those being spied upon and those doing the spying) factored significantly into the surveillance challenge.

## Lillian Robinson Scholars

A feminist scholar whose career spanned over 35 years, Dr. Lillian Robinson was Principal of the Simone de Beauvoir Institute from 2000 to 2006. She was widely recognized as one of the leading feminist theorists of the twentieth century, and her essays and books have inspired feminist scholarship around the world. Thanks to a generous donation from the **Renée B. Fisher Foundation** and the work and vision of the Foundation Board Member **Dr. Shelly Fisher Fishkin** from Standford University, the Simone de Beauvoir Institute has created a visiting scholars program as a living memorial to Lillian Robinson.

The Lillian Robinson Scholar Program is designed to attract distinguished visiting scholars working on a range of feminist research topics to the Simone de Beauvoir Institute. The program supports stays of varying lengths for scholars with a PhD. The program provides small stipends ranging from \$1000 to \$3000. Four Lillian Robinson Scholars visited our Institute in the last two years (see page 14).



I spent a full semester at the Institute, working on research for a cultural history project based in Montreal. I was amazed at how many cool people with cool projects I met, both through the space and its ongoing events programming. That contact was really helpful and inspiring. More, I found the sunny office on the top floor to be an excellent place to serve as a base-camp, to get organized, to consolidate information, and begin writing.

## Public Positions

From time to time, the SdBI gets directly involved in debates and takes a public position. This was the case in 2010 with Bill 94 as well as with the decision by Ontario Superior Court Judge Susan Himel with regards to Canada's prostitution laws. Please find on our next page summaries of these public responses and do not hesitate to contact us to show your support!

In March 2010, the government of Jean Charest announced Bill 94, an act that would prevent women wearing the nigab from accessing hospitals, daycares, schools, universities, and other public services, and would bar women in niqab from working in the public sector. In a press conference, premier Charest described the legislation as defending two principles: gender equality and secular public institutions. Representative members of the SdBI community opposed this legislation on the grounds that it will restrict rather than enhance the rights of women. As feminists, these SdBI members affirmed their commitment to supporting bodily and personal autonomy for all women, as well as all women's capacity to understand and articulate their experiences of oppression on their own terms. And it is as feminists that they opposed state interventions that promise gender equality at the expense of women's autonomy. The full April 2010 SdBI statement can be found on our web site:

In September 2010, Ontario Superior Court Judge Susan Himel made a ruling with regards to Canada's prostitution laws. The ruling argues that the current laws (e.g., communicating for the purposes of prostitution, living off the avails of a prostitute, and the bawdy house laws) create a context of increased danger for women and thus violate Section 7 of the Charter of Rights and Freedoms: the right to the security of the person. Some feminists, notably Québec's Conseil du Statut de la Femme (CSF), objected to the ruling, arguing that prostitution is violence against women. SdBI representatives prepared a position statement on the issue. The statement was presented at a press conference, alongside the voice of Stella, a local community agency by and for sex workers, as well as an ad hoc group of feminists who wrote an open letter to CSF. Together, the diverse voices represent an alternative feminist view of prostitution as work, and offer reasons why feminists need to support the decriminalization of prostitution.
