- He updated the Board on the status of the water leak in the Science Pavilion on the Loyola Campus which occurred on February 15, thanking everyone who acted with celerity and efficiency to minimize damage and disruption and safeguard equipment.

12. Report on compliance with environmental legislation and health and safety (EH&S) regulations (Document BG-2016-1-D10)

Mr. Côté noted that the continued emphasis on prevention and awareness in 2015 have translated into tangible results and have helped strengthen the safety culture at the University.

Associate Ombudsperson Julie Boncompain highlighted the statistics included in the 2014/2015 annual report. She provided a summary of the 2014/2015 recommendations and updated the Board on the progress of the implementation recommendations from previous annual reports. Following her update, Ms. Boncompain responded to comments and questions from Governors.

The President thanked Governors for their enthusiastic participation at the Board retreat. The document which was discussed at the retreat has been updated following the feedback received at the retreat. This draft will be discussed at the upcoming Senate meeting during a similar roundtable exercise to obtain input from Senators.
