Re: Fund Balance Availability Check & Empath Commitments Launching Summer 2024

ABOUT FUND BALANCE AVAILABILITY CHECKING IN UNITY:

We are pleased to announce, starting this summer the Fund Balance Availability Check (FBAC) functionality will be turned on in Unity. This system functionality is a feature which will serve the research community with a tool to prevent overspending on grants. This functionality will be very similar to the NSF (non-sufficient funds) feature which was part of the Banner environment. This tool will verify a transaction, prior to posting it to your grant, to assess if there is enough money available to cover the expense. If there isn't enough balance available, the expense will be rejected. The expense will be rejected once 100% of the budget is consumed. Below are some examples of the error message that will appear when a transaction fails due to insufficient funds in Unity is:



We are launching this feature in a phased in approach to ensure a smooth transition. When we go live with this functionality, only TRI AGENCY GRANTS will be validated for available

funds. We will continue to add on other sponsors as the year goes forward. If you have a grant from one of the TRI AGENCY sponsors below, the FBAC will be in effect pursuant to the below dates.

ABOUT EMPATH-BURSARY, FEELOWSHIPS AND SCHOLARSHIPS COMMITMENTS:

Effective with the posting date June 13th,2024 (pay period 24) all bursaries, fellowships and scholarships will be captured as commitments (also referred to as 'fund reservations') and will be deducted from your available balance. This means your available balance will be more reflective of your true balance available for spending. This important improvement will bring back to the research community a system feature to prevent overspending. The commitments column text will display the same information accessible as the actual's postings, i.e. the week of posting, the student's name and document number.

As a reminder, please ensure the internal order to charge indicated on the bursary, fellowship or scholarships forms is clearly indicated.

How the FBAC will work is - when an expense will be submitted for processing, if the expense item is greater than the available balance on the grant, the FBAC will reject the transaction and the expense will not be processed or paid out. It is the grant owner's responsibility to ensure the grant has enough money to cover all expenses being charged. Please note as empath and salary charges are contracted to the individual, they will be processed and paid.

We encourage all members charging research grants to regularly verify their grants balances on their researcher dashboard for up-to-date reporting details.
