

# Employee Sustainability Ambassadors Program Departmental approval for employee participation

The Employee Sustainability Ambassadors Program is an applied volunteer program offered through the Office of Sustainability and recognized by the university. The program has been endorsed at the level of the President's Executive Group.

## Program goals and objectives

- Increase sustainability awareness and knowledge among colleagues
- Engage colleagues in activities that advance sustainability at Concordia
- Identify actions that departments can undertake to become more sustainable and encourage their adoption
- Build relationships and knowledge capacity among colleagues

#### Overview

Staff members will spend 4 hours per month on program activities. Each month, Sustainability Ambassadors will:

- Attend a training session on a particular topic offered by program partners
- Undertake a simple audit based on the training topic and using program resources
- Present audit results and recommendations to department members and collaborate on improvement plans
- Collaborate with other Employee Ambassadors on problem-solving through a dedicated Microsoft Team

# Eligibility

Employees must have taken, or commit to take, the two-hour "Introduction to Sustainability at Concordia for Employees" professional development course.

Additionally, employees must be available to participate in the training sessions taking place by Zoom from 10 a.m. to 12 p.m. on the following dates: January 19, February 16, March 16, April 13, May 11, September 14, October 12, November 9, December 7.

Employees must obtain the approval of their manager and departmental director (or equivalent) to participate.

- Targeted training by sustainability professionals at Concordia (Office of Sustainability, Facilities Management, Hospitality Concordia, and others)
- Resources and materials to help enact change within your department
- Community-building with peers
- Annual sustainability appreciation luncheon
- Employer-supported sustainability volunteering during summer hours
- Opportunity to receive a Sustainability Champions award

### **Benefits for departments**

- Targeted, department-relative support for implementation of sustainability best practices
- Audits and implemented measures will tie directly into Sustainable Office Certification
