# New Curriculum and Calendar Software

The contract for the new curriculum and calendar management software has just been signed. The software is offered by Digarc, and consists of Curriculog, for curriculum management, and Acalog, for catalog management. Implementation plans are being made and will involve the associate deans, academic as well as the curriculum administrators in each Faculty.

# Jerusalem Field School

Twenty-three applications with research proposals and letters of recommendation were received and of them fifteen participants have been chosen for the inaugural Jerusalem Field School this summer. Selected students come from the departments of Art History, Art Education, Computation Arts, Film Production, Film Studies, Studio Arts and Theatre. Agreements have been made with a number of institutions and organizations including Musrara (The Naggar Multidisciplinary School of Art and Society), Bezalel Academy of Arts and Design, Hazira – Performance Art Arena, the Mamuta Project, the Jerusalem Academy of Music and Dance, and the Yellow Submarine. The field school will include a number of tours and workshops.

# Graduate Certificate in Entrepreneurship

JMSB is proposing a graduate certificate in entrepreneurship specifically designed to respond to the needs of graduates from diverse disciplines who are ready to start their professional practice. The program, which focuses on microbusinesses (1-5 employees) is intended for graduates or graduate students in the fine arts, social sciences, humanities, engineering and health disciplines. The program can be taken simultaneously with a graduate degree.

# Undergraduate Student Show at the FOFA Gallery

Now on view at the FOFA Gallery, Making Spaces, the annual undergraduate student exhibition. Showing from January 16 to February 17, the exhibition expands to include performers from the Department of Contemporary Dance.
