## Description

This module presents essential information and guidance about academic integrity and plagiarism within the context of completing graduate research. A range of strategies and approaches are explored to support you in successfully completing your thesis and beyond.

## Module Learning Objectives

- 1. Define academic integrity and plagiarism
- 2. Recognize instances of plagiarism
- 3. Identify and apply good collaborative practices and techniques in avoiding plagiarism
- 4. Articulate the relationship between plagiarism, academic integrity and copyright with regards to graduate level research and publication
- 5. Explain Open Access routes to publication, in particular depositing your thesis to Spectrum, Concordia University's Open Access Repository
- 6. Access and use a range of other appropriate tools and resources to successfully complete graduate studies.

## Assessment

As of Winter 2016, this module, a self-paced online tutorial, will be available but not yet required for graduate students. This will allow for testing and adjustments. We expect that the official launch will occur during the Fall 2016 semester, whereby all Doctoral and Master's students will be required to complete the module before enrolling onto their second semester.

In order to assess knowledge and understanding, students will be presented with a range of interactive case examples, scenarios, short multiple choice quizzes and other materials exploring issues relating to academic integrity and plagiarism. In each instance they will be given with a number of options or choices. Choosing an option will provide immediate feedback aligned to the learning objectives. It is expected that the assessment questions and prompts will not have clear answers and the choice may be ambiguous, providing opportunities for reflection and feedback.

## Access to the Course

All graduate students at Concordia University shall participate in the ASIM<sup>™</sup> module through the MyConcordia Portal. Enrollment will be automated and the module will be developed as a fully online course, for example through Moodle or eConcordia.

The module will take 45 minutes to complete.

## **Skills Acquired**

- By the end of this online module, students will be better able to:
  - Recognise instances of plagiarism
  - Paraphrase extracts of original text so as to avoid plagiarising
  - o Accurately reference sources within the text of a paper
  - Identify and understand the importance and application of copyright for their own and others academic work
  - Recognise and adhere to University codes of conduct on academic integrity.
  - Identify other appropriate university resources that may assist graduate students in succeeding with their projects.
