**Application process for Admission into Co-op for Undergraduate Students in the  
Gina Cody School of Engineering & Computer Science**

Students wishing to join Concordia University's Co-op Program must make an application by undertaking the following three steps, **prior to the DNE Deadline every term.**

1. Complete the **Co-op Summary Report** and **Proposed course Plan Form** for your respective program;
2. Bring the **Co-op Summary Report** and **Proposed course Plan Form** for approval to your Co-op Academic Director (see list below);
3. Submit the **approved and signed** forms to the Co-op Office (1550 Blvd. Maisonneuve W, GM 4<sup>th</sup> floor, suite430) **prior to the semester's DNE deadline, at the time of admission** (i.e. prior to mid-May, mid-September or mid-January's University DNE deadline).

When completing your “**Proposed Course Plan form**” (next page), please be sure to follow the below Co-op requirements when creating your course plan:

1. Students must have a CGPA of at least 2.5 at the time of application, and maintain at least 2.5 throughout enrollment in the program
2. Students must begin and end their course plan with a study term;
3. Students must have at least 2 **full** study terms prior to their first work term;
4. Students must return to school for a full-time study term after each work term, and return to at least part-time study after the final work term;
5. Students must complete ENCS 282 prior to their first work term;
6. Students must maintain full time status every study term, including summer semesters (12 credits or more);
7. Students must have 3 work terms prior to their final study term;
8. Students cannot schedule a work term while taking their capstone;
9. Students must do at least **one** work term in a semester other than the summer semester.

**I understand that** the Gina Cody School of Engineering & Computer Science creates a course sequence for students in the regular program and a course sequence for students in the Co-op program. If a Co-op student does not follow the course sequence created by the School, he/she runs the risk of having registration problems. This could result in delayed graduation, inability to study full-time, and the withdrawal of Co-op.

The Co-op Academic Director can propose a new course plan, **but there is no guarantee** that the new course plan will work because of the reasons mentioned above
