- 6. <u>Chair's remarks and Question Period</u> The Dean made the following remarks:

AACSB accreditation processes continue to move forward. We will need to send a letter to AACSB in mid-January and this process has given the School the opportunity to examine the strategic focus with the goal of ensuring that the assurance of learning procedure is well articulated and consistent. The process is part of a commitment to fostering and embracing continuous improvement in the Faculty and will lead us into a solid strategic plan going forward. With this in mind, the plan is to start workshops on AACSB in JMSB. This will enable individuals, administrators at first, to have first-hand training on

the language of accreditation and the workshops will then be opened up over time to all faculty and staff.

It was recently announced (Nov 7) that two of Concordia's buildings have achieved LEED certification: PERFORM (Gold) and the MB (Silver). We are very proud of this recognition from the Canada Green Building Council (CaGBC).

10. CASA Report

Mr. Dinh made the following announcements:

11. JMGSA Report

The JMGSA Speaker Series hosted a media relations workshop.

Year-end cocktails are being organized and the 2nd annual Graduation Ball will be held in April.

The MBA and MSc students, with the support of Tim Field, are looking forward to competitions at both HEC and Colorado.

12. <u>Undergraduate Curriculum Changes: Department of Decision Sciences and Management Information</u> Systems (JMSB-2012-07A-02)

There was an extensive discussion on the rationale behind the name change from Department of Decision Sciences and Management Information Systems to Supply Chain & Business Technology Management.

It was suggested, for instance, that the department look for a name that is more generic other than the specific reference to the two areas of discipline contained within the department. The Department of Management was given as an example of a department that holds the different fields such as Human Resources, Entrepreneurship, etc. included within the umbrella of the Department of Management.

The representatives of the department explained that the decision was made in part to align the department with the changes in both industry and academia as well as the certification process presently in place for the students of the respective areas.

Many individuals recognized the extensive work that the department completed in order to present the changes.

Prof. Sharma read out the elections slated and asked if there were any other nominations from the floor.

14. <u>Reports from the Associate Deans</u>
 14.1 H. Bhabra, Associate Dean, Research and Research Programs (JMSB-2012-07A-04)

Associate Dean Bhabra gave a summary of the report. He explained that there has been an increase in funding for PhD students that has brought the JMSB to a more comparable level in terms of the other local institutions. The long time to graduation was noted (approximately 7 years) and the Associate Dean has started meeting with students to address this.

There has been an increase in applications for the MSc program. However, there was a decline in the local Canadian and permanent resident category. There is limited funding available for candidates in this program and it was suggested that perhaps a benefactor or TA/RA contracts could be suggested as an additional source of income. Associate Dean Bhabra explained that another option that could be

further explored would be to have faculty members commit to a portion of their grants to hire incoming candidates as research assistants.

15. Address to Council: Dr. Alan Shepard, President and Vice-Chancellor

Dr. Shepard addressed Council and thanked the members of the Concordia community for the welcome he has received since taking office August 1.

He explained that he is looking forward to the work ahead and embraces challenges to the traditional ways of organizing education and is excited for what the future has to offer in terms of innovation, support for the traditional strengths of the institution, the blended learning environment, community involvement as well as working with the Board of Governors, Senate and academic units to reach collective goals.

Dean Harvey thanked Dr. Shepard for addressing Council and his support of the School.
