1. Call to Order

The meeting of the Open Session was called to order at 10:00am.

2. Welcome and Introductions

After a tour de table, Dr Wood-Adams introduced herself and members of the decanal team, and briefly provided an overview of the mission and objectives of the Council.

Chair's Remarks

Dr Wood-Adams provided commentary on the 2012-2013 Highlights document that was handed out to Council members. The Chair thanked Anne-Marie Croteau (in absentia) for her service to the School of Graduate Studies and welcomed Luca Caminati to the position of Associate Dean, Graduate Recruitment and Awards. An increased graduate studies presence on the portal and a new Twitter account were also announced. Looking forward to 2013-2014, the School of Graduate Studies website will be overhauled, GradProSkills will continue to develop and establish itself in Concordia's graduate landscape, and attendance at recruitment fairs will be increased 20 percent on top of the previous 40 percent increase in 2012-2013. This year's Canadian Association of Graduate Schools annual conference will be held in Montreal (3-6 Nov.) while, the American-based Council of Graduate Schools will hold its meeting in San Diego (4-7 Dec.) – both of which will see participation from the School of Graduate Studies. The Academic Programs and Development portfolio team will continue to offer support to departments seeking to cultivate new programs or conduct curriculum revisions.

5. Question Period

In response to a question about the status of possible decreased endowment payouts for 2014-2015, the administrative director was hopeful that there would not be significant decreases but that confirmation of the impact for 2014-2015 and future years would be confirmed later in the Fall, and communicated as soon as known. The Chair reminded Council members that the School allocates funding to the faculties who, in turn and without SGS intervention, redistribute those funds to individual departments.

9. Graduate Certificate in University Teaching and Graduate Education Centre: Dr Vivek Venkatesh, Associate Dean, Academic Programs and Development

Dr Venkatesh provided an overview of the Graduate Certificate in University Teaching and the eventual Graduate Education Centre to Council members. Council members raised questions about the program length (15 credits) and the uniqueness of the program in Canada. Ours is the only 'for credit' program in English, in Québec. A similar program does exist at the University of Victoria but it lacks the internship component.

- 10. Regulation Changes

Aligning the IP deadline with the DNE deadline and the IPE deadline with the end of the term will avoid the necessity of formally changing the date provided in the Graduate Calendar every year.

10.2 DNE/DISC dates for /3 courses

Currently, there is no refund for full-year courses, i.e., /3 courses, if students do not de-register by the Fall DNE deadline. The change in the Graduate Calendar establishes the Fall DISC deadline as the financial credit deadline for the WINTER portion of the /3 courses. This will allow receipt of partial financial credit for academic withdrawals initiated by the abovementioned deadline.

10.3 Academic Standing

Students who fail to submit their progress reports by the May 15 deadline will be blocked from registering for the following academic term. The addition of a registration block will ensure that students complete their progress reports; its addition in the Graduate Calendar will formalize current procedures. In addition, students whose progress reports are marked as 'Unsatisfactory' are encouraged to contact their graduate program director, although the 'Unsatisfactory' designation will not affect their academic standing. The registration block is removed once the Progress Report is submitted.

Some Council members who had previously held the position of GPD noted that they had not regularly received notice of progress reports requiring their attention. It was suggested that a systematic method of a notification be instituted for the future, and that a more detailed explanation of GPD roles in the progress report process be added to the GPD Online Guide.
