1. Call to Order

The meeting was called to order at 10:00 am.

2. Approval of the Agenda

4 Chair's Remarks

Dr Wood-Adams thanked Dr Caminati, whose term was coming to and end, for his service to the School of Graduate Studies. She expressed her appreciation for his contribution to graduate education including the establishment of the Concordia University Summer Research Institute and the Graduate Studies video series. Dr Effrosyini (Faye) Diamantoudi will be taking on the Recruitment and Awards portfolio in January. Dr Amir Aghdam will also be joining the ranks of the School, taking over the Student Affairs and Postdoctoral Studies portfolio, also in January. Dr Wood-Adams announced that the Faculties would be receiving their awards allocation on December 2. She also thanked Ms Beaudion for her willingness to take on the administration of the Graduate Awards office while an integral person was on leave.

The Chair shared her experience at a recent conference in Edmonton put on by the Conference Board of Canada who undertook a project aimed at skills development in higher education. The Conference Board of Canada recently published a report entitled 'Inside and Outside of the Academy'. While Dr Wood-Adams did not agree with all of the arguments put forth in the report, she felt that it was an important and relevant topic, and would circulate it amongst Council members.

Dr Wood-Adams welcomed Dr Niem Hyunh, the University's new Manager of Graduate Recruitment, the two of them having just returned from a PhD fair in Beijing, China. This year's China recruitment trip was much more productive than in previous years with many more interested applicants. More than 50 applications were received and would be forwarded to relevant Graduate Program Directors and Faculty Associate Deans.

The Chair announced the establishment of a new initiative, the Graduate Community Building Fund. The purpose of the project is to fund community building activities amongst graduate students such as a speaker series, colloquia, etc. The initiative comes about in response to the Canadian Graduate and Professional Student Survey (CGPSS) which identified a sense of community as an area in need of improvement; students had expressed a sense of disconnect with their departments.

5. Question Period

A Council member asked what sorts of expenses would be allowable under the Graduate Community Building Fund. Dr Wood-Adams replied that the objective is to be quite flexible and that expenses such as catering would be allowed. A recent negative report in the Globe and Mail about the status and utility of the PhD in Canada was invoked by another Council member. The Chair intended to request that the Canadian Association of Graduate Schools make a public reply to this article.

Dr Nelson requested speaking privileges for Dr Richard Courtemanche of the Department of Exercise Science. Dr Courtemanche gave an overview of the path that brought the program proposal to this point, starting with a Letter of Intent in 2009. With a flourishing master's program and several INDI PhD graduates under its belt, the department's introduction of this

new PhD program is timely and on track with current trends in fields related to health. It focuses on health, nutrition and exercise, and is an extension of Exercise Science into other health disciplines leveraging on the Perform Centre and other neighbouring health research centres and hospitals. The new program will allow faculty members and students to delve deeper into current research trends and differs from current similar programs by its integrative perspective. The Department intends to begin soft recruitment once the PhD is approved by Senate.
