4. Chair's Remarks

Dr Wood-Adams informed Council members that 16 new Horizon Postdoctoral Fellowships had recently been announced and that the Spring competition would soon be underway. She also provided members with an update on the Public Scholars project – a program designed to promote outreach, leadership and scholarship for top PhD students. This term, the School welcomed its first cohort of ten exceptional doctoral students from a broad range of disciplines.

The Chair announced that the 6th rendition of the Three Minute Project and Thesis competition where graduate students learn to present their research to a non-expert audience was to take place on March 23. She invited Council member to attend the event to witness the breadth of research at Concordia.

The School will also be establishing a new grant program for cotutelles programs. Aligned with the spirit of the Strategic Initiative, 'Embrace the World', the goal of the program is to increase Concordia's participation in cotutelles; currently, we have very few. The grant in the amount of \$5,000 will be available to new cotutelle agreements and may be used to defray typical research-related costs as is the case with seed grants.

8. Laura Mitchell, Director Student Success Centre

Dr Wood-Adams welcomed Dr Mitchell to the Council. Dr Mitchell provided members with a brief biographical sketch as well as an overview of the services available at the Student Success Centre. Dr Mitchell joined Concordia three years ago after a teaching career in psychology which included the supervision of graduate students.

Dr Mitchell explained that the services previously offered under Counselling and Development have been separated into two units, Campus Wellness and Support Services, which focusses primarily on mental health issues, and the Student Success Centre; her presentation focused on the services available in the latter. In addition to paying special attention to first year undergraduate students, the Student Success Centre also offers services in academic skills development, career planning, English and French language support, access to learning

specialists, and time management. The Writing Centre, the Career and Planning Service (CaPS) and the Career Resource Centre, amongst others, are housed in the auspices of the Student Success Centre. Dr Mitchell invited members to visit the Centre's future space in the Hall Building which is currently in the design stages.
