6. Calendar Revisions for Thesis

CSGS 2223 5 D1

Drs Diamantoudi and Pawelek presented a summary of revised thesis regulations that were recommended by a working group with representation from each of the faculties, the INDI program and the School of Graduate Studies' decanal team.

The goal of the revised regulations is to establish a single, consistent and concise source and to guarantee the integrity of the regulations, all the while facilitating the process. The working group investigated the practices in place at 13 sister institutions; its primary focus was the composition of the examining committee and the adjudication procedures.

The examining committee will now be composed of the supervisor, two examiners, one examiner at arm's length, and an external examiner. A pathway exists for non-traditional examiners, such as community elders. Henceforth, the committee can take one of two decisions: to accept or not accept. A thesis may be resubmitted for examination within 6 months; a second decision not to accept will result in a rejection.

The revised regulations will return to Council for final approval at the next meeting.
