The broader objective of this course was for students to be able to describe, explain and analyze how global and local environmental issues are regulated by legal institutions and frameworks. More narrow objectives included: the role of environmental law in the Canadian legal system; Identification, summarization, and evaluation of the legal approaches to environment case law; The role and function of environmental regulatory and assessment laws; And demonstration of how operational policies and managerial approaches are influenced by the legal standing of the environment and natural resources.

This course examines the gendered aspects of legal institutions. This entailed impressing the position that law forms a backdrop to negotiations about our sexualities and our sexed and gendered identities. The same course also explored how the law both produces and regulates our sexual subjectivities and gendered selves as good/bad, healthy/harmful, and natural/unnatural. Our case studies drew on critical race, gender, sexuality, legal theories, criminal and constitutional law and cases. The rationale for structuring the course in that manner was due to the belief that one's sex, gender and sexuality cannot be divorced from other axes of identity, such as race, class, and disability.

My research was funded by the Department of Indian Affairs (now CIRNAC). An offshoot of the same research explored restorative justice, which culminated in guest lectures and policy work with the Aboriginal Justice Directorate, Department of Justice (Ottawa, Ontario). This entailed supporting hundreds of community-based justice programs in collaboration with Indigenous communities.
