#### MAJOR FIELDS OF SCHOLARLY OR PROFESSIONAL INTEREST

My research centers on the liberation, well-being, and rights of Indigenous peoples in Canada and internationally. I focus particularly on violence—both interpersonal and state-perpetrated—examining how Indigenous women, youth and communities respond to violations of dignity and safety. My work investigates the contexts of violence, including the actions of perpetrators, explores responses and resistance, and analyzes their connections to identity, sovereignty, Indigenous well-being, and decolonization.

A significant portion of my research addresses the systemic issue of Missing and Murdered Indigenous Women in Canada and Indigenous resistance to disappearance globally. I examine both structural and interpersonal violence, generating knowledge about the ongoing safety challenges faced by Indigenous women. My work highlights their experiences through storytelling and initiatives such as "Indigenous Healing Knowledges" and explorations of cultural safety.

I am passionate about bringing survivors' stories to the fore. Highlighting our interconnections and experience(s) as people(s) from all over the world is crucial for our sense of shared humanity. In my role as co-founder of the Centre for Response-Based Practice, I find ways to disseminate information about this approach to violence prevention and recovery. This study involves a focus on preserving and uplifting human dignity, illuminating responses to adversity and orchestrating positive social responses towards people who have been harmed. Within these parameters, I have an interest in Indigenous child welfare transformation and developed a model called "Islands of Safety" to be used as a safety-planning process with Indigenous families. In addition to focusing on the well-being and safety of Indigenous women, I also enact a youth-focused approach. I was involved in a national study examining structural violence against youth in Canada in an arts-based, participatory action study. I have extended my conceptualization of safety and integrity to include land, the environment and peaceful co-existence with Earth. This relates to my family's experience living in the shadow of uranium mining and gas/oil extraction and suffering the consequences thereof.

My interest in decolonizing systems includes the development and implementation of dignity-centered and anti-oppressive approaches in child welfare settings. I am advancing knowledge and practice to support children who have been in state care through increased family connectedness and cultural participation. This research is situated within a larger epistemological framework of understanding the interconnectedness between personal, collective, and ecological well-being, in alignment with an Indigenous worldview. I am also a psychotherapist and clinical supervisor in private practice in Montreal, since 2017, working with Indigenous survivors of residential school. This is important for me for maintaining activity in direct service to inform my teaching and research. As an educator, I apply Indigenous pedagogies such as circle-work, integrated ritual, historical and discourse analysis and Indigenous understandings of life-span development.
