  - This briefing to the Minister of Justice (Quebec) involved the proposed introduction of a written Quebec Constitution.
  - The CAQ government introduced Bill 1 (Quebec Constitution Act 2025) on 9 October 2025.
  - My advice to the Minister of Justice was rejected and is not reflected in Bill 1 (Quebec Constitution Act 2025).
    - I advised the re-introduction of bicameralism in Quebec, with an elected upper house, based on a modified version of proportional representation.
    - I advised the introduction of a constitutional provision specifying that the notwithstanding provisions in the Canadian Charter of Rights and Freedoms, and the Quebec Charter of Human Rights, could only be used in response to judicial invalidation by either the Quebec Court of Appeal or the Supreme Court of Canada.
    - This advice, if accepted, would preclude the pre-emptive use of the override provisions of the Canadian and Quebec Charters that occurred in Bills 94 and 96 (Charter of the French Language).
1. James B. Kelly, Written brief submitted to Hunter Litigation Chambers in regard to litigation before the Supreme Court of Canada involving *Conseil scolaire francophone de la Colombie-Britannique*.
  - I was retained by Hunter Litigation Chambers, on behalf of the Attorney General of British Columbia, to write a brief (30 pages) evaluating the implementation of all policy responses to judicial declarations of rights and freedoms, focusing on time-frames and statutory responses, 1982-2024.
